
AN ORDINANCE ESTABLISHING COMPENSATION FOR EMPLOYEES OF
THE VILLAGE FOR YEAR 2012 AND DECLARING AN EMERGENCY.

WHEREAS, this Council has determined that the employees of the Village have served their community with high standards and devotions to duty.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bentleyville, County of Cuyahoga, State of Ohio, that:

- Section 1.** Effective December 25, 2011, employees of the Village shall be compensated in accordance with the following provisions set forth at Exhibit "A" attached hereto and incorporated herein by reference.
- Section 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.
- Section 3.** This Ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, or safety of the inhabitants of the Village and for the further reason set forth in the preamble hereof, and this Ordinance shall, therefore, take effect and be in full force immediately from and after the date of its passage and approval.
