ORDINANCE NO: 2013-34

AN ORDINANCE CREATING A NEW SUBSECTION OF THE CODIFIED ORDINANCES OF THE VILLAGE OF BENTLEYVILLE NUMBERED 276.01 AND ENTITLED "COMPOSITION AND PURPOSE OF THE BOARD OF TAX REVIEW" AND DECLARING AN EMERGENCY.

WHEREAS, The Village of Bentleyville needs to establish the Composition and Purpose of the Board of Tax Review.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bentleyville, Ohio County of Cuyahoga, State of Ohio, that:

Section 1 The Village of Bentleyville hereby adopts a new subsection in the Codified Ordinances numbered 276.01 and entitled "Composition and Purpose of the Board of Tax Review" and section 276.01 shall read as followed:

276.01 COMPOSITION AND PURPOSE OF THE BOARD OF TAX REVIEW

The Board of Tax Review shall consist of the Mayor, the Director of Law and the Fiscal Officer. The Board shall select each year for a one-year (1 yr.) term one of its members to serve as Chairman and one to serve as Secretary. A majority of the members of the Board shall constitute a quorum. The Board shall adopt its own procedural rules and shall keep a record of its transactions. Such records are not public records available for inspection under Section 149.43 of the Revised Code. Hearings requested by a taxpayer before the Board of Review created pursuant to this section are not meetings of a public body subject to Section 121.22 of the Revised Code or ordinances of the Village.


Section 2 This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village and for the further reason that the Composition and Purpose of the Board of Tax Review be established so any appeals filed by taxpayers can be timely held.


