AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH ATWELL'S POLICE AND FIRE EQUIPMENT CO. AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Bentleyville has hired five new part time police officers and said officers need a firearm;


WHEREAS, Council for the Village of Bentleyville has determined that the Village of Bentleyville needs to purchase firearms for the new officers.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bentleyville, Ohio, County of Cuyahoga, State of Ohio, that:

- Section 1.** Council for the Village of Bentleyville hereby authorizes the Mayor to enter into the attached agreement with Atwell's Police and Fire Equipment Co. to purchase 5 model 17 or 19 Glock firearms.
- Section 2.** Council for the Village of Bentleyville hereby authorizes the Fiscal Officer to appropriate and pay the sum of Two Thousand Forty Five Dollars and 00/100 (\$2,045.00) to said company from fund no. 411 for the purchase of the firearms.
- Section 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.
- Section 4.** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village and for the further reason that the five new officers are being sworn in on November 21, 2013.




