ORDINANCE NO: 2017-10

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH LOVE INSURANCE AGENCY FOR THE PROVISION OF GENERAL LIABILITY, POLICE PROFESSIONAL, PUBLIC OFFICIAL, AUTOMOBILE, AND PROPERTY INSURANCE FOR THE VILLAGE, AT THE TOTAL AGGREGATE COST NOT TO EXCEED \$29,896.00 AND DECLARING AN EMERGENCY.

WHEREAS, LOVE INSURANCE AGENCY has submitted a quotation to the Village for the time period of March 28, 2017 to March 28, 2018 for the provision of general liability, police professional, public official, automobile, and property insurance for the Village, from various insurance carriers and underwriters, at a total aggregate cost not to exceed \$29,896.00


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BENTLEYVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1. The Mayor is hereby authorized to enter into a contract with Love Insurance Agency for the time period of March 28, 2017 to March 28, 2018 for the provision of general liability, police professional, public official, automobile, and property insurance for the Village, at the total aggregate cost not to exceed \$29,896.00

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.

Section 3: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village and for the further reason set forth in the preamble hereof, and this Resolution shall, therefore, take effect and be in full force immediately from and after the date of its passage and approval.


