**AN ORDINANCE REQUIRING THE FISCAL OFFICER OF CUYAHOGA COUNTY TO  
ADVANCE ALL TAX REVENUE AND SPECIAL ASSESSMENTS COLLECTED IN THE  
YEAR 2019 TO THE VILLAGE OF BENTLEYVILLE AND DECLARING AN EMERGENCY**

**WHEREAS**, from time to time during the fiscal year 2019, before and subsequent to tax settlement dates, the Village of Bentleyville will undoubtedly require funds for the continuity of necessary services, which funds are drawn from General Operating Funds; and

**WHEREAS**, this Council respectfully requests the Fiscal Officer of this County to advance funds and deduct such advances from funds due this Village, but not distributed, including Bentleyville's Special Assessments Funds; Water Line Assessment No. 9890 and Road Resurfacing & Repair Bond No. 9891.

**BE IT ORDAINED** by the Council of the Village of Bentleyville, County of Cuyahoga and State of Ohio, that:


**Section 1.** The Fiscal Officer of this County is respectfully requested to advance all tax revenues and special assessments collected in year 2019 to the Village of Bentleyville's Special Assessments Funds; Water Line Assessment No. 9890 and Road Resurfacing & Repair Bond No. 9891 and that the amount of such advance or advances be charged to the Village of Bentleyville and deducted from funds due the Village but not distributed. The Clerk should certify a copy of this Ordinance to the County Fiscal Officer.

**Section 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.


**Section 3.** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village of Bentleyville and for the further reason set forth in the preamble hereof, and this Ordinance shall, therefore, take effect and be in full force immediately from and after the date of its passage and approval.


