ORDINANCE NO: 2018-27

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH CHAGRIN VALLEY PAVING IN AN AMOUNT NOT TO EXCEED \$269,176.90 FOR THE CHAGRIN RIVER ROAD & VILLAGE HALL PARKING LOT RESURFACING AND DECLARING AN EMERGENCY.

WHEREAS, Chagrin Valley Paving has submitted a bid to the Village for the Chagrin River Road & Village Hall Parking Lot Resurfacing and not to exceed \$269,176.90; and

WHEREAS, the infrastructure improvement herein above described is considered a priority need for the community; and

WHEREAS, Council has determined that Chagrin Valley Paving is the lowest and best bidder for the project.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BENTLEYVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1: The Mayor is hereby authorized to enter into a contract with **Chagrin Valley Paving** in an amount not to exceed Two Hundred Sixty Nine Thousand One Hundred Seventy Six Dollars and 90/100 (\$269,176.90) for the Chagrin River Road & Village Hall Parking Lot Resurfacing.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.

Section 3: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village and for the further reason that the Village wants to enter into a contract with Chagrin Valley Paving, as soon as possible.


