ORDINANCE NO: 2018-28

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH NORTHCOAST ROOFING, INC. IN AN AMOUNT NOT TO EXCEED \$27,835.00 TO REPLACE ROOF ON VILLAGE HALL AND TO REPLACE THE FLAT ROOFING ON MAIN ENTRANCE OF VILLAGE HALL AND ENTRANCE OVER REAR STAIRWELL AND DECLARING AN EMERGENCY.

WHEREAS, Northcoast Roofing, Inc., has submitted a bid to the Village for the replacement to the flat roofing on the main Village entrance and entrance over rear stairwell and not to exceed \$27,835.00; and

WHEREAS, Council has determined that Northcoast Roofing Inc., is the lowest and best bidder for the project.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BENTLEYVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1: The Mayor is hereby authorized to enter into a contract with **Northcoast Roofing, Inc.**, in an amount not to exceed Twenty-Seven Thousand Eight Hundred Thirty Five and 00/100 (\$27,835.00) for the replacement to the Village Hall roof and the flat roofing on the Village Hall's main entrance and entrance over rear stairwell.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.

Section 3: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village and for the further reason that the Village wants to enter into a contract with Northcoast Roofing Inc. as soon as possible.
