AN ORDINANCE AMENDING CHAPTER 1426, RESIDENTIAL CODE OF OHIO FOR ONE, TWO AND THREE FAMILY DWELLINGS BY ADDING A PENALTY SECTION TITLED 1426.99, OF THE VILLAGE OF BENTLEYVILLE CODIFIED ORDINANCES, AND DECLARING AN EMERGENCY

WHEREAS, the Council for the Village of Bentleyville finds it within the best interests of the Village to amend Chapter 1426, titled Residential Code of Ohio for One, Two and Three Family Dwellings by adding penalty section titled 1426.99, for the betterment of the community and Village of Bentleyville; and

BE IT ORDAINED by the Council of the Village of Bentleyville, County of Cuyahoga and State of Ohio, that:

- Section 1. Therefore Chapter 1426 shall be amended and Chapter 1426.99, Penalty Section shall be added to read as attached.
- Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.
- This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village of Bentleyville and for the further reason set forth in the preamble hereof, and this Ordinance shall, therefore, take effect and be in full force immediately from and after the date of its passage and approval.

CHAPTER 1426.99

Penalty

Whoever violates or fails to comply with any of the provisions of this chapter, including the provisions of the Residential Code of Ohio for one, two and three family dwellings adopted by reference in Section 1426.01, is guilty of a misdemeanor of the third degree and shall be fined not more than five hundred dollars (\$500.00) or imprisoned not more than sixty days, or both, for each offense. A separate offense shall be deemed committed each day during or on which a violation or noncompliance occurs or continues.
