ORDINANCE NO: 2018-49
INTRODUCED BY: GOETSCH

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH NORTHCOAST ROOFING, INC. IN AN AMOUNT NOT TO EXCEED \$250.00 FOR ADDITIONAL COSTS AND EXPENSES TO REPAIR AND REPLACE THE SCREEN GUTTERS FOR ALL FLAT ROOFS AND DECLARING AN EMERGENCY.

WHEREAS, Northcoast Roofing, Inc. ("Northcoast"), had submitted a bid to the Village for the replacement to the flat roofing on the main Village entrance and entrance over rear stairwell and not to exceed \$27,835.00; and

WHEREAS, pursuant to Ordinance No. 2018-49, City Council passed an Ordinance authorizing the Mayor to enter into the contract; and

WHEREAS, pursuant to Ordinance No. 2018-49, City Council passed an Ordinance authoring the Mayor to enter into a contract for the repair and replacement of the Cupola roof shingles; and

WHEREAS, the original quote and supplemental quote did not include the work necessary for the repair and replacement of the screen gutters for all flat roofs; and

WHEREAS, due to aforesaid unforeseen circumstance, the cost and expenses to do the additional repairs was not included in the original contract price or supplemental contract price; and

WHEREAS, Northcoast has submitted a proposal for the additional costs and expenses to not exceed \$250.00;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BENTLEYVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The Mayor is hereby authorized to enter into a contract with **Northcoast** in an amount not to exceed Two Hundred and Fifty Dollars (\$250.00) for the additional costs and expenses to repair and replace the gutters for all flat roofs.


Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.

Section 3. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village and for the further reason that the Village wants to enter into a contract with Northcoast as soon as possible.


