ORDINANCE NO: 2019-30
INTRODUCED BY: GOETSCH

AN ORDINANCE AMENDING 2019-23 TO REFLECT THAT SECTION 6(A) OF CHAPTER 890 OF THE VILLAGE ORDINANCES WAS TO BE AMENDED AND NOT CHAPTER 880.12 OF THE CODIFIED ORDINANCES OF THE VILLAGE AND DECLARING AN EMERGENCY.

WHEREAS, this Council has determined that the employees of the Village have served their community with high standards and devotions to duty; and

WHEREAS, the Council for the Village of Bentleyville passed Ordinance 2019-23 which provided for the amendment of Chapter 880.12 of the Codified Ordinances of the Village of Bentleyville regarding Municipal Income Tax; and

WHEREAS, the Council for the Village, with the passage of Ordinance 2015-29, explicitly intended that Title Four, Chapter 880 of the Bentleyville Codified Ordinances be repealed; and

WHEREAS, the Council for the Village finds it is within the best interests of the Village to amend Ordinance 2019-23 by deleting any reference to Section 880.12 and inserting Section 6(A) of Chapter 890.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bentleyville, Ohio, County of Cuyahoga, State of Ohio, that:

Section 1. Council for the Village passed Ordinance 2019-23 which amended the income tax credit from .25% to .125%. Ordinance 2019-23 incorrectly referenced that Section 880.12 was to be amended. The correct section to be amended was Section 6(A) of Chapter 890 of the Ordinances of the Village of Bentleyville. Therefore, Ordinance 2019-23 is hereby amended to reflect that Section 6(A) of Chapter 890 be inserted in place of Section 880.12.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village.


