## AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE CITY OF NEWTON FALLS FOR THE SALE OF A USED POLICE VEHICLE AND DECLARING AN EMERGENCY

WHEREAS, Ohio Revised Code 735.053 allows a City or Village to purchase vehicles from any other political subdivision without necessity of bidding as long as that purchase is authorized by legislative authority of that political subdivision; and

WHEREAS, Council wished to authorize the Mayor to enter into an agreement with the City of Newton Falls, allowing Newton Falls to purchase a used 2014 Ford Taurus Police Interceptor vehicle from the Village of Bentleyville which will be in the best interest of the health, safety and welfare of all Village Department by disposing of this used vehicle.

**NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bentleyville, County of Cuyahoga and State of Ohio:**


**Section 1:** The Mayor is hereby authorized and directed to enter into an agreement with the City of Newton Falls which would allow the City of Newton Falls to purchase a used police vehicle from the Village of Bentleyville that being a 2014 Ford Taurus Police Interceptor, VIN FAHP2MK8RG163005 for the purchase price of Five Thousand Five Hundred Dollars (\$5,100.00) which shall be paid upon delivery.

**Section 2:** That the Mayor is authorized to execute any documents to affect the sale of this Police Interceptor to the City of Newton Falls.

**Section 3:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.
