**ORDINANCE NO: 2021-18**  
**INTRODUCED BY:**

**AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A  
CONTRACT WITH THE DAVEY TREE EXPERT COMPANY IN AN  
AMOUNT NOT TO EXCEED \$7,500.00 FOR THE REMOVAL OF  
TREES AND DECLARING AN EMERGENCY**

**WHEREAS**, The Davey Tree Expert Company (“Davey Tree”) has submitted a bid to the Village for the removal of trees in an amount not to exceed \$7,500.00; and

**WHEREAS**, Council has determined that Davey Tree is the lowest and best bidder for the project.

**BE IT ORDAINED** by the Council of the Village of Bentleyville, County of Cuyahoga and State of Ohio, that:

**Section 1.** The Mayor is hereby authorized to enter into a contract with Davey Tree in an amount not to exceed \$7,500.00 for the removal of trees.

**Section 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.




