**AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A
CONTRACT WITH AMERICAN LEGAL PUBLISHING FOR THE
CODIFICATION OF ORDINANCES FROM 2018 FORWARD IN AN
AMOUNT NOT TO EXCEED \$6,574.00 AND DECLARING AN
EMERGENCY**

WHEREAS, American Legal Publishing has submitted a proposal in the form and substance attached hereto as Exhibit "A" to the Village for the Codification of Ordinances in an amount not to exceed Six Thousand Five Hundred Seventy Four Dollars and 00/100 (\$6,574.00); and

WHEREAS, Council has determined that American Legal Publishing was the vendor who last codified the Village Ordinances and is best vendor suited for the project.

BE IT ORDAINED by the Council of the Village of Bentleyville, County of Cuyahoga and State of Ohio, that:

Section 1. The Mayor is hereby authorized to enter into a contract with American Legal Publishing in an amount not to exceed Six Thousand Five Hundred Seventy Four Dollars and 00/00 (\$6,574.00) for the Codification of Village Ordinances.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.




