ORDINANCE NO: 2022-18
INTRODUCED BY:

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH THE VALLEJO COMPANY IN AN AMOUNT NOT TO EXCEED FIVE THOUSAND FIVE HUNDRED DOLLARS FOR ASPHALT PAVEMENT REPAIR ON PINE RIVER DRIVE AND DECLARING AN EMERGENCY

WHEREAS, The Vallejo Company has submitted a bid to the Village for the Asphalt Pavement Repair on Pine River Drive in an amount not to exceed \$5,500.00; and

WHEREAS, Council has determined that The Vallejo Company is the lowest and best bidder for the project.

BE IT ORDAINED by the Council of the Village of Bentleyville, County of Cuyahoga and State of Ohio, that:

Section 1. The Mayor is hereby authorized to enter into a contract with The Vallejo Company in an amount not to exceed \$5,500.00 for the Asphalt Pavement repair on Pine River Drive.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.




