**AN ORDINANCE AUTHORIZING AN AMENDMENT TO THE
MEDICAL MUTUAL OF OHIO CONTRACT FOR THE PROVISION OF
HEALTH CARE INSURANCE COVERAGE TO ALL FULL-TIME
VILLAGE EMPLOYEES AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to Ordinance 2021-43, Council authorized the Mayor to enter into a contract with Medical Mutual of Ohio for the provision of health care insurance coverage to all full-time employees.

WHEREAS, the Village Fiscal Officer has indicated the need to revise the contract price for the insurance coverage.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BENTLEYVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:


Section 1. Village Council, upon the recommendation of the Village Fiscal Officer, hereby approves the increase of \$17,062.56 of the contract price.

Section 2. Village Council hereby authorizes the Fiscal Officer to amend the contract with Medical Mutual of Ohio to \$85,210.68.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village and for the further reason set forth in the preamble hereof, and this Ordinance shall, therefore, take effect and be in full force immediately from and after the date of its passage and approval.
