MAYOR'S REPORT: 00:01:33

Gabe Barone, Police Chief

The Mayor complimented and congratulated Fiscal Officer Nickol Sell on the audit in which there were no findings. He discussed putting a motion on the agenda to extend the Kimble contract and asked Fiscal Officer Nickol Sell to find out the 2024 cost to the village. The Mayor asked that the record reflect that Councilman Rubin arrived at 7:06 p.m.

Mayor Spremulli reported that he, Jeff Filarski and Matt Maistros met with Cleveland Metroparks representatives last month including Chief Planner Sean McDermott. They presented the site plans, and the Mayor let them know our minimum needs for the facility as well as some additional items we would like if they could be worked into the plan. He also asked for some financial options. Jeff Filarski suggested recladding our building to make it compatible with what the other buildings will look like. The Metroparks will make a site visit and will get back in touch.

Mr. Nemer reported that he and the legal council met with Mr. Filarski re: Zupon litigation. They are
going to prepare him for the site visit. With regards to Schultz, the legal team wanted to take the
depositions the Chief, Sergeant Cutwright and Sergeant Manson on July 10th but Mr. Nemer told them
it would be difficult for Bentleyville to have them all gone on the same day, so they will be in contact
to schedule a future meeting.

 Mr. Filarski's report is on file. Mr. Filarski reported that the Miles Road bridge project has been delayed due to slow material reviews. However, it is still slated for 2023. Mr. Kvacek asked if Mr. Filarski was able to stop at the new home on Solon Road to check on the front yard landscaping. He reported that he did and is satisfied with it.

- Mr. Kvacek inquired about the fire inspection cost and the cost of the new extinguishers. Chief Barone explained that several needed to be replaced. In addition, one was used to extinguish a shed fire and had to be recharged.

• Nothing to report. Mayor Spremulli noted that Anthony left to focus on his own landscaping business. He reported that the flagpole has been moved. Kathleen Hale will purchase two new flags. Mr. Kvacek asked about the windshield replacements. Per Mr. Maistros they were the result of the chipper and the weed wacker throwing debris. He noted that the chipper is not built for the amount of chipping the village has and he will most likely need to call Kimble to pick up a load. The service department does not have the room to store all the branches and it would take several months to chip them all.

 The Committee report is on file. Councilman Kvacek commented on what a good job Service Director Matt Maistros and the service department is doing, noting the sign area, moving the flagpole, clearing of the corner village property on Overlook and finding the material for a new topcoat for the Bocci Ball Court (which is being paid for by the league). It is the 9th season and has had the largest crowds in all 9 years. He also noted that Shakespeare in the park has moved to Friday July 21st. He reported that the crabapple trees that need replaced have been identified and we are now trying to locate where to purchase them. Finally, he reported that the ad hoc committee for the millstone has reviewed locations for its placement and is recommending our property on Overlook Road. The original stone is in Chagrin Falls and he is in contact with the owners to see if they would be interested in trading. Mr. Maistros wanted to note for the record that he was told to cut down the tree that is on the property. Discussion regarding the Japanese Lilac began. Kathleen Hale objected to cutting it down. Mr. Kvacek noted the tree is not in good shape and it was decided to try to trim the dead branches and see how it does and see if the millstone can still be placed there.
