**A RESOLUTION AUTHORIZING THE MAYOR TO PLACE CERTAIN
SPECIFIC ITEMS OF VILLAGE PROPERTY UP FOR SALE ON THE
GOVDEALS, INC. AUCTION WEBSITE AND DECLARING AN
EMERGENCY**

WHEREAS, GovDeals, Inc. offers an on-line product that functions as an auction site for the sale of publicly owned property to the general public; and

WHEREAS, the Village has entered into a Memorandum of Understanding with GovDeals, Inc. governing the terms and conditions of the parties' relationship;

WHEREAS, the Village wishes to auction off certain items of property through the GovDeals website; and

WHEREAS, the Village has determined that the items to be auctioned off are either obsolete or unfit for the use for which they were originally acquired or no longer needed by the Village;


BE IT RESOLVED by the Council of the Village of Bentleyville, County of Cuyahoga and State of Ohio, that:

- Section 1.** Council hereby authorizes the Mayor, in accordance with the terms and conditions of the Village's Memorandum of Understanding with GovDeals, Inc., to put certain items up for auction on the GovDeals, Inc. website, said items as set forth in Exhibit A hereto, the terms of which are incorporated herein by reference as if fully re-written.
- Section 2.** Following passage of this Resolution, the Village shall comply with the notice requirements of R.C. 721.15 by publishing, in a newspaper of general circulation in the Village, notice of the Village's intent to sell by internet auction the items set forth on Exhibit A, including a summary of the information set forth herein. Said notice shall be provided at least twice, and the subsequent notice shall be published not less than ten or more than twenty days after the previous notice.
- Section 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.

Section 4. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village of Bentleyville and for the further reason set forth in the preamble hereof, and this Resolution shall, therefore, take effect and be in full force immediately from and after the date of its passage and approval.




