### MAYOR'S REPORT: 00:01:18

Mayor Spremulli reported that Kathleen Hale has filed to run for Mayor and she is running unopposed. Bob Chalfant and Alex Goetsch have filed petitions to run for Council and are also running unopposed. The Mayor unofficially congratulated them, noting that he wanted to wait for voting before he officially congratulated them. Per Mayor Spremulli, this will be a smooth transition. He will include Kathleen in any mayoral decision making. He will try to get a draft budget together in September and then sit down with Kathleen and work with her to finalize a budget before the end of the year.

The Mayor also reported that our Service Department employee Larry Millstein quit, so Matt Maistros is the only person currently working in the department. An interview will be conducted tomorrow for a new full-time employee. Mr. Maistros believes two full time employees will work in the service department. Ideally, we would like to get a person in place before leaf season.

Kathleen Hale and Ryan Rubin have a meeting with Kimble to discuss a possible contract extension.

Mr. Filarski's report is on file. Mr. Filarski noted that the plans are ready to bid for the Riverview Park
improvements. The location has been selected for the permanent bathroom structure and the
current delivery time for the structure is six months. The paving, drainage and bioretention cell can
be bid out this year. Per Mr. Filarski waste will go into a container and when cleaned will get sucked
out.

- Chief Barone reported that a restructure of the police pay scale will be presented to council.
  Discussion regarding the difficulties finding officers ensued. The mayor pointed out that we need to
  be on top of our pay scale to attract candidates and also that police departments are calling to try to
  recruit officers from other departments.
- Chief Barone acknowledged two of our officers, Daniel Peacock and Sarah Hoover were involved in a lifesaving incident recently.

### SERVICE DIRECTOR REPORT: 00:12:49

• Mr. Maistros reported that all the salt has been received and the small amount outside the bin has been tarped. In addition, he started to cut some of the roadsides back which look a little bit burned up right now. However, as the grass grows it will look a lot better. He also reported that the corner should be done by the end of the month depending on when we hire another employee due to the fact that the remaining work will require two people. Chagrin has not yet been able to jet and vacuum the culverts on Chagrin River, but they have assured Mr. Maistros that they will. Mr. Maistros contacted the county who then sent court community service individuals to the village to pick up litter which has been an issue lately, especially on Cannon and Liberty as well as Chagrin River Road. Finally, Mr. Maistros reported that things are on a good schedule right now, all branches have been picked up and the sickle bar will be delivered Friday.
