**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH LEXIPOL FOR USE BY THE POLICE DEPARTMENT AND DECLARING AN EMERGENCY.**

**WHEREAS** Lexipol provides first responders with expert policy, training and wellness support; and

**WHEREAS** Council has determined that the services provided by Lexipol is a necessity for the Police Department.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Bentleyville, County of Cuyahoga, State of Ohio, that:

**Section 1.** The mayor is hereby authorized to enter into an agreement with Lexipol so that the police Department can obtain the necessary services provided by Lexipol.

**Section 2.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.

**Section 3.** This Resolution is hereby declared to be an emergency measure immediately necessary for the public peace, health, or safety of the inhabitants of the Village and for the further reason set forth in the preamble hereof, and this Resolution shall, therefore, take effect and be in full force immediately from and after the date of its passage and approval.
