WHEREAS, the Countywide 9-1-1 Program Review Committee for Cuyahoga County, Ohio has unanimously approved the Final Plan for Countywide 9-1-1 Services throughout Cuyahoga County, and has submitted the same for approval by the Board of County Commissioners and the various municipal and township legislative authorities within Cuyahoga County;
