NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BENTLEYVILLE, CUYAHOGA COUNTY, OHIO AS FOLLOWS:

- Samuel Alai is hereby selected by the legislative authority of the Village of Bentleyville, Ohio to serve as the municipal representative on the Cuyahoga County 9-1-1 Program Review Committee.
- Section 2. This matter constitutes an emergency as the membership is to be selected on or by May 1 of each year and a fully appointed and functioning 9-1-1 committee is necessary for the benefit of the health, safety and welfare of the Village and this resolution shall take effect and be in full force upon final passage.
- Section 3. In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.
- Section 4. It is hereby found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
