MAYOR'S REPORT: 0:00:32 Ms. Hale and Ms. Papa identified the residents whose grass has been cut by the Village for the past number of years. Ms. Hale advised them by mail and by phone that June 1st will be the date the Village will stop cutting the grass. Some of the residents asked if the Village would continue to cut the grass for a fee, Ms. Hale responded "no" due to time constraints of the service department and other reasons. The Mayor looked into a vendor presentation Chief Barone had seen previously for a grant writing service. Ms. Hale spoke with the individual and was impressed with his credentials. She sent the contract to Mr. Nemer to review and he had some specific questions which Ms. Hale then took to the vendor, who agreed to further refine the contract. Ms. Hale believes this service will pay for itself. Mr. Nemer encouraged Ms. Hale to ask what grants he has received previously. Ms. Hale agreed and said she would get it in writing. There are many documents that are cleared for shredding. Quotes will be obtained. Carpet cleaning for Village Hall is scheduled for next week. Mr. Kvacek has highlighted three items in Village Hall that need replaced or repaired. Once the proposals are obtained they will be presented in July. Ms. Whitmyer and Ms. Hale discussed updating the Village's logo.
