AN ORDINANCE AMENDING ORDINANCE 2023-35 ESTABLISHING COMPENSATION FOR EMPLOYEES OF THE VILLAGE OF BENTLEYVILLE FOR THE YEAR 2024, AND DECLARING AN EMERGENCY

WHEREAS Ordinance 2023-35 was adopted Council and signed by the mayor to establish compensation for employees of the Village of Bentleyville for the year 2024; and

WHEREAS it is the desire of Council to increase add a position under the Service Department called Craftsman/Driver Part-Time Plow with an hourly rate of \$40 per hour.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bentleyville, County of Cuyahoga, State of Ohio, that:

Section 1: Exhibit A to Ordinance 2023-35 is hereby and herein amended to read as follows:

Under Service Department, Craftsman/Driver Part-Time Plow with an hourly rate of \$40.00 per hour.

- Section 2: The remainder of Exhibit A to Ordinance 2023-35 shall remain in full force and effect, unless inconsistent with this Ordinance.
- Section 3: All other Village Codified Ordinances shall remain in full force and effect, unless inconsistent with this Ordinance.
- Section 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including the applicable sections of the Ohio Revised Code.
- This Ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, or safety of the inhabitants of the Village and for the further reason that the Village of Bentleyville wants to immediately add a classification under the Service Department for a Craftsman/Driver Part-Time Plow to Exhibit A to Ordinance 2023-35 of the Village of Bentleyville. This Ordinance shall, therefore, take effect and be in full force immediately from and after the date of its passage and approval.
