ORDINANCE NO: 2024-52 INTRODUCED BY: GOETSCH

AN ORDINANCE AMENDING SECTION 452.01, PROHIBITION AGAINST PARKING ON STREETS, OF THE VILLAGE OF BENTLEYVILLE CODIFIED ORDINANCES AND DECLARING AN EMERGENCY

WHEREAS, Ordinance No. 452.01 of the Bentleyville Codified Ordinances adopted the language found in Ohio Revised Code Section 4511.66 for the Prohibition Against Parking on Streets or Highways; and

WHEREAS, the Safety Committee of the Village of Bentleyville has recommended revision of Section 452.01 by adding subsections (c) and (d) to prohibit parking on Village streets during a snow emergency; and

WHEREAS, the Safety Committee of the Village of Bentleyville has recommended that Section 452.01 be revised accordingly.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BENTLEYVILLE, OHIO:

Section 1. That Section 452.01 of The Village Ordinances is amended as follows:

- (c) When on the traveled or paved portion of any street in the Village there is a snowfall of two inches or more standing, a "snow emergency" shall exist and parking on such street or streets shall be prohibited. Any car parked on the street when two inches of snow is accumulated shall be removed forthwith so that the paved portion is clear for the passage of snow plows.
- (d) Whoever violates this section is guilty of a minor misdemeanor on a first offense; on a second offense within one year after the first offense, the person is guilty of a misdemeanor of the fourth degree; on each subsequent offense within one year after the first offense, the person is guilty of a misdemeanor of the third degree.
- Section 2. That it is hereby determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including the applicable sections of the Ohio Revised Code.

Section 3. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village of Bentleyville and for the further reason set forth in the preamble hereof, and this Ordinance shall, therefore, take effect and be in full force immediately from and after the date of its passage and approval.
