A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH HUNTER CONSTRUCTION INC. FOR THE INSTALLATION OF A SEPTIC TANK FOR THE BATHROOM AT RIVERVIEW PARK AND DECLARING AN EMERGENCY


WHEREAS Hunter Construction Inc. has submitted a proposal to the Village for the installation of a septic tank for the bathroom at Riverview Park in an amount not to exceed \$1,750.00.

WHEREAS, Council has determined that the installation of a septic tank for the bathroom at Riverview Park is necessary.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bentleyville, County of Cuyahoga, State of Ohio, that:

- Section 1:** The mayor is hereby authorized to enter into a contract with Hunter Construction Inc. in an amount not to exceed \$1,750.00 for the installation of a septic tank for the bathroom at Riverview Park.
- Section 2:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements.
- Section 3.** This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village and for the further reason that it is necessary to reconcile the final amounts.
